GULUNAP' PROJECT
DEVELOPMENT OF A MEDICAL FACULTY
AT THE UNIVERSITY OF GULU
AGREEMENT BETWEEN
THE UNIVERSITY OF NAPLES FEDERICO II IN ITALY

THE UNIVERSITY OF GULU (GU) IN UGANDA

The Rector of the University of Naples Federico II in ITALY and the Council of the University of Gulu, in the framework of a general collaboration agreement between the two Universities, with the aim of developing a new Faculty of Medicine at the University of Gulu, agree that :

Art 1

The two parties shall collaborate in the development of a Faculty of Medicine at the University of Gulu according to the objectives and programme approved by the Ugandan Government and the Italian Embassy in Uganda (Annex I), through the project named 'GULUNAP'.

Art 2

The project shall last three years from the date of signature by both parties and in any case from from the date of the transfer of funds to the University of Naples referred to in Article 5 below, and ends at the end of the scheduled period. It may be renewed if funds dedicated to it by Governments or other agencies are found.

Art 3

The UNIVERSITY of Naples will provide:

- Collaboration in the construction of the Curriculum
- Technical supervision of the project in Uganda
- Secretarial management in ITALY
- Professors on Short Mobility for each semester of the first 3 years of course, to run compact courses lasting 4 weeks in Uganda, and advise on programmes, learning objectives, tutoring and learning objectives, tutoring and assessments.

Art 4

The University of Gulu will provide:

- Co-ordination and co-operation in the construction of the curriculum
- The management of the Project under the supervision of the Dean of Faculty.
- The recruitment of personnel according to Ugandan laws
- Space and equipment to enable effective collaboration by by the Italian professors on mission.
- Overall management of students and all teaching activities of each semester

Art 5

To meet the expenses related to the GULUNAP programme, the University of Gulu will receive, from the Ugandan Minister of the Treasury , with the approval and signature of the Italian Ambassador in Uganda , as a consequence of the signing of the agreement, the sum of US\$ 515,000 (Five hundred and fifteen thousand US Dollars) , while US\$ 275,000 (Two hundred and seventy five thousand US Dollars) shall be transferred to the bank account of the University of Naples, with employment restriction defined in the budget approved by both parties (Attachment 1)

Art 6

This agreement shall be effective for a period of three years from the date of the last signature, but however from the date of the transfer of funds to the University of Naples. The agreement may be renewed by the explicit mutual consent of the parties when appropriate financial resources have been guaranteed.
